## PRESIDENT MESSAGE BY MICHAEL J. LANDI

Let me apologize for the long time between newsletters. There has been a load of issues going on since the last newsletter. In December, NYCT President Veronique Hakim attended our meeting and spoke to the membership, she acknowledged that she was aware of the problems and issues we managers have been experiencing. During her Q&A she informed the membership that she would continue to communicate with our Executive Board. I was glad to see so many of our members in attendance to welcome her.

After many meetings with the MTA regarding the MTA Bus managers pension, I, and our attorney Stuart Salles are happy to finally announce that an agreement between the MTA and the TMBA has officially been reached and the MTA Board approved the pension plan. I must thank Stu for his dedication and hard work, for the long hours and days working on the pension plan. I am also happy to announce that our efforts have paid off, and effective July 1, 2017, there will be a 2% salary adjustment for all Managerial, Confidential Secretaries and Non-Represented Career & Salary Employees. Please obtain the July 11, 2017 memo from Patricia A. Lodge, Vice President Human Resources.

It is our understanding that Human Resources this year issued new Managerial Performance Review (MPR) guidelines. The new forms can be obtained on TENS. We suggest our members make sure their MPR is current and that you are on target to achieve your goals.

We also understand, that there may have been a letter going around suggesting that our members contact the TMBA Executive Board or Members of the Council by utilizing MTA-NYCT email and phones. All TMBA members are reminded that you must refrain from utilizing MTA email and telephones for other than transit business. If you need to communicate with the TMBA, use your personal e-mail or telephone to call us.

The "Additional Member Contribution Refund Bill" passed in Albany was signed into law by Governor Cuomo. For information on receiving your "Additional Member Contribution Refund," I suggest you call, or visit, your respective pension plan representative. However, NYCERS is dragging its feet in complying with the law. We are attempting to rectify the problem.

Speaking of NYCERS, there will be a Cost of Living Adjustment (COLA) this September for retirees age 62 or older and retired for five or more years. The adjustment equals 1.2% for a maximum annual increase of \$216.00, or \$18.00 per month before taxes. The adjustment is applied up to the first \$18,000 of your Single Life Allowance.

At our June meeting, we accepted nominations for Council Member. Those wishing to serve as council member had to be a TMBA member only, and had to be nominated and seconded by a member from that candidates' section. Council Members serve a term of three years.

As per the Camp Lejeune Historic Drinking Water Program-The Department of Veterans Affairs finalized a new rule on 13 January to consider eight diseases as presumptive for service connection. This service connection provides VA disability benefits for veterans who have one of eight diseases and served for 30 days or longer (consecutive or nonconsecutive) on permanent or temporary duty at camp Lejeune, NC between 1 August 1953 and 31 December 1987. The eight



diseases covered under the new rule are: adult leukemia; aplastic anemia and other myelodysplastic syndromes; bladder cancer; kidney cancer; liver cancer; multiple myeloma; non-Hodgkin's lymphoma; and Parkinson's disease. The Marine Corps is working to identify and notify individuals who may have been exposed to the chemicals in the drinking water. On Election Day, Tuesday, November 6, 2017, voters in New York State may be asked to vote to see if a convention be convened to revise and Amend the New York State Constitution. Two items affecting civil service retirees and future retirees. (1)-Pensions cannot be diminished; (2)- Civil Service Pensions are exempt from New York State Income Tax. A change in the constitution could change or eliminate these provisions. We are encouraging our members living and voting in New York State to "VOTE NO" on any changes to the Constitution affecting Civil Service employees, retiree's, or their beneficiaries.

Unfortunately, Mr. Rosenfeld does not advise on MTA Bus Pensions or MTA HQ Pensions. We are working on information for the MTA Bus Company Managers and hope to provide help with their retirement options in the future.

Our annual award dinner will be held on Friday, the 3rd of November. This year's award recipients will be Edwin (Eddie) Melendez who will be awarded our "Manager of the Year Award," Department of Buses and Frank Jezycki, Vice President/Chief Maintenance Officer, Division of Car Equipment who will be awarded "Manager of the Year Award," Department of Subways. We look forward to seeing all our members in attendance to honor our awardees.
