There are multiple opportunities available for Bus Operators who have a passion for public service. Our goal is to provide our customers with safe, reliable, and clean buses, while delivering excellent customer service.

BUS OPERATORS, under general supervision, operate a bus carrying passengers in accordance with the rules and regulations of MTA, New York State law and New York City traffic regulations. They ensure proper payment of fare; issue and collect transfers; ensure passengers' safety; protect the assigned vehicle; write reports concerning revenues, accidents, faulty equipment and unusual occurrences and perform related work.

SPECIAL WORK CONDITIONS: Bus Operators may be required to work various shifts including nights, Saturdays, Sundays and holidays.

DRIVER LICENSE REQUIREMENT: At the time of appointment you must have either (A) a "Class B" Commercial Driver License (CDL) valid in New York, with a passenger endorsement and no disqualifying restrictions that would prevent you from performing the duties of this position.; or (B) a Motor Vehicle Driver license valid in New York for a minimum of three years by the time of appointment and a CDL Learner Permit passenger endorsement and no disqualifying restrictions that would prevent you from performing the duties of this title.

The current minimum salary for a Bus Operator is \$23.84 per hour, increasing to \$34.06 in the sixth year of service. The benefits of this position include, but are not limited to, paid holidays, vacation and sick leave, a comprehensive medical plan and pension plan.
